IMPORTANT: Examples of work must be submitted to the Dandelion Art Curator to be considered for exhibition. Three artists per month will be featured. Drop-off for all artworks will be on the first Sunday of the selected month.

Dandelion Communita House, whereas, the artist wishes to have certain artworks represented by DCH, and whereas, DCH wishes to represent the artist under the terms and conditions of this agreement.

1. The artist hereby warrants that he/she created and possesses unencumbered title to the artwork(s), and that their description is true and accurate.
2. Duration of Consignment. The artist and DCH agree that the initial term of consignment for the artwork(s) is to be the duration of the month selected by the Dandelion Art Curator, and that the artist does not intend to request the return of the artwork(s) before the end of this term.
Please pick up artwork(s) on the date given at the time of drop-off.
Note: All artwork must be delivered and picked up by the artist *within the deadline specified*.
All unclaimed artwork will become property of DCH 30 days after the pick-up deadline.
3. Transportation Responsibilities: packing and shipping charges, insurance costs, other handling expenses, and risk of loss or damage incurred in the delivery of artwork(s) from the artist to the exhibit location, and in the return to the artist, shall be the responsibility of the artist.
4. Commissions: DCH will receive a 25% commission on the sale of artwork. The artist shall receive 75% of the price of the artwork sold.
5. Shipping sold artwork: It is the responsibility of the artist to ship and insure all sold artwork to the buyer.
6. Documentation: artist must completely fill out application, listing artwork, medium, size, and any discount available to buyers. Artist is responsible for attaching easily identifiable information to the back of work.
7. Loss or Damage: DCH takes no responsibility in any way for loss, stolen or damaged artwork(s) and property. DCH does not insure artist's work(s) in any way. Artist exhibits all work at their own risk.
8. Copyright: It is the artist's responsibility to insure and protect the copyright of his or her own artwork.
9. Presentation: **All artwork(s) must be gallery ready**, meaning (if two-dimensional) matted, glassed, framed, (Framing does not apply to paintings on stretched canvas) and a **sturdy** hanger wire on back. Please specify if three-dimensional work.
10. Modifications: All modifications to this agreement must be in writing and signed by both parties. This agreement constitutes the entire understanding between the parties hereto.
11. Governing Law: The laws of the State of Florida IN WITNESS shall govern this Agreement whereof; the parties hereto have signed this Agreement as of the date first set forth above.
